How will you be using your 67 minutes? #My67Minutes

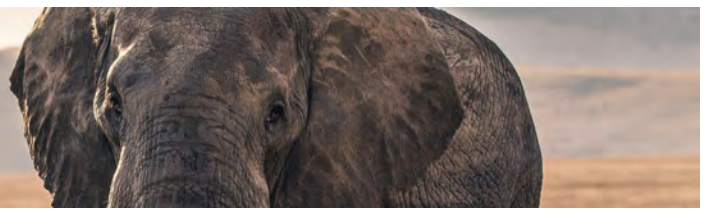

The South African Revenue Services (SARS) has announced that taxpayers will be able to file their tax returns from 1 July 2022.

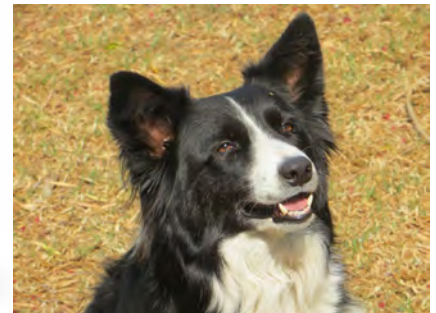
